Business

1. Secretary's Report

December's meeting minutes approved. Bill firsts. Tim seconds.

2. 2025 Budget

Brought up for approval. Heatherly firsts. Benson seconds.

3. Community Foundation for SBC Investment Account

Decided to move ahead and invest with the CFSBC so that we can receive better consideration for community grants. The Board requests Ron to talk to an adviser there and invest an initial amount of \$7500.

Benson firsts. Tim seconds.

4. Solar panel on DOC Roof

Grant application opens on May 8th and closes Jun 5th. Sara volunteers to write grant request to fund this project. Other questions came up about how to determine the total amount to request in the grant.

For example, is the roof structurally sound? If not, we will need to request additional funds in the grant to ensure the roof is structurally sound. How about the nearby trees, with potential for damage as a result of the wind blowing down the branches onto the solar panels, damaging them?

5. Quartermaster's Report

Billy wants to learn how to load the asset tagger software called Asset Tiger onto a tablet and scan assets. Mel needs to give Billy an account and transfer the administrative role to Billy. Billy added that he wants to schedule field trips to repeaters so that he knows their locations and can help with repairs/maintenance.

6. DOC Upgrades/Maintenance/Repairs

Bryan's wife to bring ceiling tiles and replace the ones in the DOC. Still looking into getting a bid to replace the carpets. Possible flooring installers: Steve Franco through Superior Stone in Gilroy, CA, *not* Blue Ribbon Concepts in Hollister, CA. In general, we have had issues with Blue Ribbon Carpets.
